Exhibitors interested in these onsite advertising items should submit their applications with a deposit of at least 20% of the advertising fee to HKTDC by the intention deadline of 29 July 2022.

If more than one application is received for a particular item or location, allotment will be arranged by way of balloting, and ballot priority will be given to exhibitors who have confirmed for onsite advertising items at the 2020 October edition of Electronics Fair and Lighting Fair. Successful applicants will receive a confirmation letter from HKTDC. The balance payment of the confirmed advertising item must be received by HKTDC within 5 working days from the issue date of the confirmation letter. Applications received after the intention deadline will be handled subject to stock availability on a first-come-first-served basis.





All onsite advertising items at the abovementioned fairs in October 2022 will be offered on a one-off basis. Exhibitors, who have confirmed and paid for onsite advertising items at the 2020 edition of the abovementioned fairs, will be given the first right of renewal to retain the same item and location as the 2020 edition when applying for the 2023 edition of the same fair.
